County 250 Organizing Grants

Reason: Kick-start your county's celebration and tourism planning efforts.

Eligibility: Only Official County 250 Committees or a fiscal agent on their behalf

Amount: \$3,000/ County | Non-Competitive

Match or Cost Share Required: No.

Grant Distribution: All upfront for Counties/Municipalities | Other Entities 80% upfront, 20% at completion of paperwork



Local Museum Style Panel Grants

Reason: Create American Revolution indoor interpretive panels, telling local American Revolution stories.

Amount: Up to \$5,000 | Competitive

Amount: Up to \$10,000 | Competitive
